WINTER STORAGE AGREEMENT

1. Winter Storage – September 1 to May 31.
2. I hereby authorize the work described on page 1 to be done along with the necessary materials, and hereby grant my permission to operate the boat, motor(s) and trailer as necessary for the purpose of said work (including testing and/or inspection).
3. An express mechanics lien is hereby granted and acknowledged on boat, motor(s) and trailer to secure the amount of repairs hereto.
4. I agree that Island Marine Center is not responsible for any loss or damage to said boat, motor(s), trailer and contents resulting from vandalism, theft, fire, wind, rain, ice, part failure, collision, act of God or any cause beyond their control. I understand it is my responsibility to maintain a valid marine insurance policy including liability coverage on all unit(s) stored with Island Marine Center.
5. A service charge of 1.5% per month will be added to all balances not paid within 30 days of invoice date.
6. I agree to be personally responsible for all attorney fees incurred by Island Marine Center to collect any outstanding balances due.
7. Island Marine Center can not be held accountable for freezing damage caused to boat, motor(s) and/or trailer made available for pick-up or dropped off after November 15.
8. Winterization of fresh water accessories is mandatory for all boats stored by Island Marine Center
9. Due to insurance regulations no independent contractors, service organizations or outside individuals will be allowed to perform work or enter the facility without first obtaining permission. Additionally, all contractors, organizations or individuals will be required to provide Island Marine Center with a certificate of insurance coverage. Said certificate shall include coverage for liability and worker's compensation.
10. All boats not scheduled for launch by May 31 will be charged for summer storage.
11. I authorize Island Marine Center to charge my credit card number listed on page 1 of this agreement for any invoice not paid upon the completion of the work performed or within 10 days of receipt of invoice.
